 - b) Bank receipt of tender fee and Bank draft of earnest money in favour of Registrar, P.U. Chandigarh will be deposited by the eligible firms for issue of tender forms upto 04.07.2011 till 1.00 p.m. only. Tender shall be issued up to 5 p.m. on 04.07.2011.
2. The firm should have completed three similar nature of works with equal cost of 40% value of the work with one work in Govt. Deptt. or two similar nature of work with equal cost of 60% value of the work or one similar nature of work with equal cost of 80% value of the work during the last seven years ending last day of the month previous to one in which the application are invited and furnishes the performances certificate for the same shall be eligible for issue for the Tender form.
3. Pre tender meeting of firms that will be issued tender forms will be held on 04.07.2011 at 5.00 p.m. in the office of Executive Engineer-I.
4. The tender form will be received by the undersigned in his office on 07.07.2011 upto 5 p.m. and will be opened on 08.07.2011 at 10.00 a.m. in the presence of the tenderers or their representatives.
