- 4. The tenders will be opened in the meeting of JPC in presence of tenderers or their representatives who may like to be present at that time.
- 5. Panjab University does not take any responsibility for any postal delay in delivery by Registered/Speed Post or lost in transit of the tender form. No tender will be entertained by hand/courier/ Ordinary post.
- 6. The Contractor shall be responsible for mowing and weeding of lawns as and when required, cutting of hedges and maintenance of beds and maintenance of road berms in front side of houses regularly throughout the year.
- 7. Irrigation to the lawns and hedges etc. shall be taken care of by the contractor as and when required with the water hose available with the residents of the houses.
- 8. No water charges shall be deducted from the bills of Contractor.
- 9. All kinds of tools and plants and other hand tools like lawn mover, hedge shearer, hand hoe, spade etc. shall be provided by the contractor to his workers at his own cost in sufficient quantity.
- 10. Work can be carried on six days of the week between 8.00A.M. to 6.00P.M.
- 11. Contractor shall be responsible for any kind of theft or any other loss which is caused by workers.

- 12. All kind of inputs including plant material required to be planted in any of the house shall be provided by the university free of cost and the same shall be maintained by the contractor.
- 13. The contractor shall not remove any tree or any part of it from any house or from the road side without the approval of the Divisional Engineer (Hort.). The contractor can be prosecuted or challaned for such acts under rules and regulations.
- 14. Any tree\shrub and part of it removed with approval of the Divisional Engineer (Hort.). from any place within the Panjab University campus shall be the property of the university
- 15. All kinds of waste material regulated out of cutting grass\hedges etc. shall be disposed off by the contractor to the nearby garbage collection point.
- 16. Contractors bound to supply the list of maximum number of contract labour employed to be engaged on any day through each contract.
- 17. Rates should be quoted both in words and figures in tender.
- 18. Conditional and unsigned tender will not be accepted.
- 19. 2% earnest money of the total estimated cost will be deposited by the firm in the shape of Bank Draft in favour of **Registrar**, **Panjab University**, **Chandigarh** payable at Chandigarh alongwith its tender.
